August Meeting Minutes

CALL TO ORDER by LSA President Hilary Pohn at 7:06pm. The meeting was held virtually via Zoom, minutes recorded by LSA Secretary Mary Vaughn.

Requested by-laws were sent to Jon for review regarding financial updates and document retention policy.
