**Event Overview:**

The **2023 LSA Fire & ICE** is a sanctioned skating exhibition open to LSA full, associate, collegiate and adult members. The exhibition will take place on **Thursday, July 27, 2023** at Iceland Sports Complex, 1701 UPS Dr., Louisville, KY, from approximately 5:00 – 7:00 PM. **The Fire segment will be skaters performing competitive programs.** **The ICE segment will be skaters performing showcase solos or duets/trios.**

**ELIGIBILITY:** Fire & ICE is open to all current LSA members as outlined above. Membership for the 2023-2024 season must be renewed on or before July 1, 2023 to maintain eligibility to perform.

**General Event Parameters:**

**Fire:** Skaters performing a competitive program of any level.

**ICE:** ICE is open to all levels and all showcase types including duets and trios. event program. ICE programs should be appropriate in length for the skater's level and not exceed 2:30 for any level.

Participants are limited to a maximum of 1 showcase, 1 duet and total of 3 numbers overall.

*Each skater will be scheduled to a group. The Fire groups who have passed the Juvenile free skate test will have a 5-minute warm up prior to performing their program. ICE groups and Fire skaters who have not passed the Juvenile free skate test may not have a 5-minute warm up, depending on the number of entries.*

**SPECTATOR TICKETS:** Spectator tickets will be available for at the door only for \$5.00, cash, credit or check payable to LSA.

**REFUND POLICY:** Entry fees will not be refunded after the close of entry date unless the event is cancelled. There will be no refunds for medical withdrawals. The online processing fees are not refundable.
